Career & Technical Education Transfers are approved for specific Programs of Study only. Career Academy Transfers are limited to an annually approved number of students. A transfer shall not be approved that would limit the educational opportunities of resident students. Admitting a transfer student shall not require more than a minor adjustment to the existing programs offered by the District. In approving transfers, the Superintendent or designee shall consider availability of space and instructional staff, the student's disciplinary history, and attendance records.

The Superintendent has the authority to accept or reject any transfer request, provided that such action is without regard to race, religion, color, sex, disability, or national origin.

The Superintendent or his designee has the authority to revoke transfers. Transfer students shall follow all rules and regulations of the District, including, but not limited to,

REVOCATION District policies and regulations, the Student Code of Conduct, and attendance requirements. **Failure to fulfill any of these responsibilities may result in the immediate revocation of the transfer agreement.**

_____ I understand that the transfer request is granted conditionally on student behavior. The transfer can be revoked at any time including, but not limited to, during the school year, if my student engages in serious or persistent misbehavior that violates the District's Student Code of Conduct.

_____ I understand that this transfer request is granted conditionally on student attendance, including tardies. The transfer can be revoked at any time including, but not limited to, during the school year, if my student is truant, excessively absent and/or excessively tardy to class.

_____ I understand that this transfer request is granted conditionally on compliance with the District's and campus's policies. The transfer can be revoked at any time including, but not limited to, during the school year, if my student arrives to school before the scheduled arrival time or departs from school after the scheduled departure time.

_____ I understand that this transfer request is granted conditionally on the district remaining in compliance with Civil Action 5281. The transfer can be revoked at any time including, but not limited to, non-compliance with this court order. *CA5281 states "the defendants shall not approve transfers where the effect of such transfers will change the majority or minority percentage of the school population, based on average daily attendance in such districts, by more than one percent in either the home or the receiving district..."*

_____ I understand that a transfer request and a transfer agreement are required to be renewed annually.

_____ I understand that falsifying information on an enrollment document is subject to immediate revocation. Falsification of information is a Class A Misdemeanor and can lead to legal action.
